

**LAKES WEST WOMEN'S GOLF ASSOCIATION**  
**BOARD MEETING MINUTES**  
**April 6th, 2026**

- A) **Secretary's Report:** A motion was made by Candy Tashlikowich to accept the minutes. It was seconded by Kate Butchko and carried.
- B) **Treasurer's Report:** Bonnie Harvey reported. Current balance is \$5,742.60. A motion was made by Teri DeLorm to accept the treasurer's report. It was seconded by Patsy Hobert and carried.
- C) **Team Play:** Kate Butchko reported. She felt overall the season went well. Teri DeLorm reported on Team Fun Day. There were 98 participants which was down but she thought it went well and was a fun event.
- D) **Tournaments:** Polly Thompson reported for Peggy Brown. Discussion was held on teeing off from the yellows vs teals. Bonnie Harvey made a motion that we table deciding whether to be flighted by Index or flighted by choice. Also, it is to be tabled until the Nov. Board Meeting. Teri DeLorm seconded the motion and it was carried.
- E) **Octogenarian:** It was reported that there were 92 participants at Lakes East.
- F) **POD/Ringer/Golf Genius/Website:** Patsy Hobert reported. We enter our scores into Golf Genius and the POD person does the money determination.

Summer league starts the first of June. It will be the Better 9, front or back. The North Ladies are deciding where to play as their course is closing. If they join us please welcome them.

The POD calendar for 2027 is done.

Ringer results: Polly Thompson and Terry Klatt will be figuring this out. They are thinking they will pay 4 places in each flight.
